

Senate Bill (SB) 1383 Two-Cart Residential Organics Recycling Program FAQ



HOA communities with two-cart collection (trash and recycling only), have two options to comply with SB 1383. HOA property managers may select *either* a three-cart co-collected green waste and food waste program for every resident *or* provide a communal/shared location(s) for *only* food waste collection.



SB 1383 & How it Affects You

What is SB 1383?

In September 2016, former Gov. Jerry Brown signed into law SB 1383, establishing methane emissions reduction targets in a statewide effort to reduce emissions of short-lived climate pollutants in various sectors of California's economy. SB 1383 establishes targets to achieve a 75% reduction in the level of the statewide disposal of organic waste by 2025. Organic waste includes both food waste and other green waste, such as yard trimmings. Part of this law requires cities to establish organics recycling programs to all properties, including single-family residential properties, multi-family residences, and businesses. Is everyone required to recycle organic waste?

Yes, all single-family residences, multi-family properties, and commercial businesses in California are required to recycle their organic waste per SB 1383.

Will this program affect my refuse collection rate?

Yes, rates will cover the costs of collecting and processing organic waste. More information on the new service rates for two-cart customers can be found here: cityofirvine.org/recycling-waste/two-cart-waste-collection.

Can I opt out of the new organics recycling program/what if I do not produce any organic waste?

There are no waivers or exemptions for residential locations. Per SB 1383, the City must provide organics collection service to all residents, regardless of waste generation. All residents will be required to receive and participate in this service.

Can I continue to compost at home?

Yes! Residents are welcome to continue composting at home. For tutorials, please visit the Backyard Composting and/or Worm Composting links located at cityofirvine.org/composting.

Does SB 1383 require residents to start composting at home?

No, residents are not required to compost at home, though they may continue to do so voluntarily. The law requires cities to provide organics collection service to all residents. Food waste service will be included as part of WM's curbside collection program.

Are residents required to donate food?

No, SB 1383 only requires certain businesses, such as major supermarkets and grocery stores, to donate edible food. However, if you would like to volunteer or donate food, please reach out to your local food pantry to see how you can help.

Residential Food Waste Recycling Program

I only have two carts for trash and recycling, and do not have a green waste cart. What options do HOAs have for residential food waste recycling?

HOA communities with two-cart collection (trash and recycling only) have two options to comply with SB 1383. HOA property managers may select *either* a three-cart co-collected green waste and food waste program for every resident or provide a communal/shared location(s) for *only* food waste collection. Only one program option should be selected for the entire community. Once your HOA has decided on a program, the City and WM can provide technical assistance with setting up the program. Only HOA property managers are authorized to make changes to the community; individual HOA residents should not contact the City or WM Customer Service to add food waste collection.

How do I separate food scraps from the trash at home?

You may keep food waste separate from the trash by having a separate container or food scraps pail inside your kitchen. Alternatively, you may keep food inside your fridge or freezer using a container, and empty directly into the collection container on collection day.

Will I get a kitchen food scraps pail?

Residents who live in single family dwellings will receive a kitchen scraps food pail from WM starting in April 2023. Additional indoor food waste pails and containers can be purchased at various retail stores and online marketplaces.

What will happen to the food waste being collected?

Food waste will be diverted from the landfill and processed into compost or renewable energy.

When can I start combining food scraps and yard trimmings in the organics cart?

The start date of the program will depend upon which option the HOA community selects. Further details regarding proper organic waste disposal will be shared once an option has been selected.

Acceptable & Unacceptable Materials

What materials should be placed in each container currently?

What kind of waste can I place in my organics container once the new program begins?

Acceptable items in the organics (co-collected green waste and food waste) cart will include grass, leaves, small branches, shrubs, brush, plants, weeds, garden trimmings, sawdust, cooked and uncooked meat, fish, poultry, dairy products, fruits, vegetables, bread, pasta, rice, grains, eggs/eggshells, coffee/tea grounds, and food-soiled paper/napkins.

HOA communities that opt for a communal cart program will differ slightly. Acceptable items in the food waste-only container include cooked and uncooked meat, fish, poultry, dairy products,

fruits, vegetables, bread, pasta, rice, grains, eggs/eggshells, coffee/tea grounds, and food-soiled paper/napkins.

What if I put my food waste in the trash?

If you continue to place food waste and yard trimmings in the trash bin, contamination charges may be assessed. It is crucial that you sort your waste properly so that it can be recycled and handled safely. Placing trash, recyclable, or organic material into the incorrect container is considered contamination. Where do I put large palm fronds?

These should be placed in the trash cart.

Can I place compostable or biodegradable products in the organics container?

Acceptable items will differ depending on the organics program your HOA selects. Please contact your HOA/property manager to confirm your organics program and acceptable materials.

Can I use plastic bags to collect my food waste?

Acceptable items will differ depending on the organics program your HOA selects. Please contact your HOA/property manager to confirm your organics program and acceptable materials.

How to Keep Containers Clean & Fresh

How do I avoid odors in the organics container?

Consider lining your curbside cart with yard trimmings before disposing of your food scraps. Alternatively, you can use a paper bag to collect and dispose of your food waste in the organics cart or line the bottom of the cart with newspaper. You may also keep your cart in a shaded area if possible.

Inside the kitchen, consider using a container or pail with a closed lid and/or charcoal filter to alleviate odor. Empty your indoor container in your curbside collection cart frequently. To maintain freshness, keep food scraps bagged in the fridge or freezer until collection day. Sprinkling some baking soda or dried coffee grounds on top of your food scraps may also alleviate potential odor. Wash and dry indoor food scraps pail frequently to avoid odors.

Will WM offer a cleaning service for my collection carts?

No; however, residents may contact a third-party cleaning service if desired.

Will the food waste program attract pests?

This should not be the case. Residents have always disposed of food waste; now it will just be put in a different color container. To avoid attracting unwanted pests in any of your collection containers, we recommend always keeping the lid closed and only leaving containers curbside on collection day.
