GENERAL OVERVIEW

Executive Summary

The City of Irvine (City), California has been allocated \$56 million of American Rescue Plan Act (ARPA) – State and Local Fiscal Recovery Funds (SLFRF) to address the impact and recovery of the COVID-19 pandemic and address opportunities needed to prepare for future such events in alignment with U.S. Treasury Rules. As of June 30, 2023, the City has received its complete allocation of \$56 million.

At the December 6, 2021 and April 26, 2022, City Council meetings, the Councilmembers approved the City calculated revenue loss for the twelve-month period ended December 31, 2020 and December 31, 2021 of \$34.3 million and 22.1 million respectively. The total declared revenue loss has been used for government services.

As of June 30, 2023, all funds have been expended.

Uses of Funds

As of June 30, 2023, all funds have been expended for government services through a declared revenue loss.

Promoting equitable outcomes

All funding was expended for government services as a result there were no projects that promoted Equitable Outcomes.
