## **GENERAL OVERVIEW**

### **Executive Summary**

The City of Irvine (City), California has been allocated \$56 million of American Rescue Plan Act (ARPA) – State and Local Fiscal Recovery Funds (SLFRF) to address the impact and recovery of the COVID-19 pandemic and address opportunities needed to prepare for future such events in alignment with U.S. Treasury Rules. As of June 30, 2022, the City has received its complete allocation of \$56 million.

At the December 6, 2021 and April 26, 2022, City Council meetings, the Councilmembers approved the City calculated revenue loss for the twelve-month period ended December 31, 2020 and December 31, 2021 of \$34.3 million and 22.1 million respectively. The total declared revenue loss has been used for government services.

As of June 30, 2022, all funds have been expended.

#### **Uses of Funds**

As of June 30, 2022, all funds have been expended for government services through a declared revenue loss.

#### Promoting equitable outcomes

All funding was expended for government services as a result there were no projects that promoted Equitable Outcomes.
