A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF IRVINE, CALIFORNIA, SETTING PRIORITIES FOR FILING WRITTEN ARGUMENT(S) REGARDING A CHARTER AMENDMENT SUBMITTED AT A SPECIAL MUNICIPAL ELECTION TO BE HELD ON MARCH 5, 2024, AND DIRECTING THE CITY ATTORNEY TO PREPARE AN IMPARTIAL ANALYSIS

WHEREAS, a Special Municipal Election is to be held in the City of Irvine, California, on March 5, 2024, at which there will be submitted to the voters the following Charter Amendment:

Shall a City Charter amendment that (i) increases the membership of the City Council from five to seven, with the new membership comprised of a mayor and six Council members, and (ii) provides for the transition	YES
om at-large elections to by-district elections for the x Council members, with the district boundaries as escribed in City Council Resolution No. 23-88, be dopted?	NO

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF IRVINE, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the City Council authorizes the following member(s) of its body

Mayor Farrah N. Khan In Favor

Vice Mayor Tammy Kim In Favor/Against

Councilmember Larry Agran In Favor Councilmember Mike Carroll In Favor

Councilmember Kathleen Treseder In Favor/Against

to file written argument(s) not exceeding 300 words regarding the Charter Amendment as specified above, accompanied by the printed name(s) and signature(s) of the author(s) submitting it, in accordance with Article 4, Chapter 3, Division 9 of the Elections Code of the State of California. The argument(s) may be changed or withdrawn until and including the date fixed by the City Clerk after which no arguments for or against the Charter Amendment may be submitted to the City Clerk.

The argument(s) shall be filed with the City Clerk, signed, with the printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument. The argument(s) shall be accompanied by the Form of Statement To Be Filed By Author(s) of Argument.

SECTION 2. That the City Council directs the City Clerk to transmit a copy of the Charter Amendment to the City Attorney, unless the organization or salaries of the office of the City Attorney are affected.

- a) The City Attorney shall prepare an impartial analysis of the Charter Amendment not exceeding 500 words showing the effect of the Charter Amendment on the existing law and the operation of the Charter Amendment. If the measure affects the organization or salaries of the office of the City Attorney, the City Clerk shall prepare the impartial analysis.
- b) The analysis shall include a statement indicating whether the Charter Amendment was placed on the ballot by a petition signed by the requisite number of voters or by the governing body of the city.
- c) In the event the entire text of the Charter Amendment is not printed on the ballot, nor in the voter information portion of the voter information guide, there shall be printed immediately below the impartial analysis, in no less than 10-point type, the following: "The above statement is an impartial analysis of Ordinance or Measure \_\_\_. If you desire a copy of the Ordinance or Measure, please call the election official's office at 949-724-6205 and a copy will be mailed at no cost to you."
- d) The impartial analysis shall be filed by the date set by the City Clerk for the filing of primary arguments.

SECTION 3. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
