RECOMMENDED ACTION

Dissolve the Senior Citizens Council Facilities Subcommittee and the Strategic Plan for Aging Subcommittee.

EXECUTIVE SUMMARY

Irvine Senior Citizens Council (Senior Council) serves as an advisory body to City Council on policy matters affecting older adults and their families. Member participation in committees at both the County and local level is important to remain informed on matters affecting older adults.

Senior Council is requested to dissolve its Facilities Subcommittee and the Strategic Plan for Aging Subcommittee.

ANALYSIS

Senior Council subcommittees advise Senior Council and staff on matters affecting Irvine older adults, including programs and services at Lakeview Senior Center, Rancho Senior Center, and Trabuco Center. Meeting schedules for the following subcommittees are presented on Attachment.

Facilities Subcommittee – Provides input on safety and maintenance needs of senior center facilities. Provides recommendations to Senior Council and staff on proposed facility improvement projects.

Strategic Plan for Aging Subcommittee – Remains current on regional and City strategies for the development of programs and services for Irvine seniors. Provides input on yearly action items and serves as ambassadors by sharing input from senior community members. Provides support in the development and implementation of Irvine aging plan initiatives.

The recommendation to dissolve the Facilities Subcommittee is in response to reduced subcommittee participation and attendance, along with the lack of active facility improvement projects throughout Lakeview Senior Center, Rancho Senior Center, and Trabuco Center. In place of the bi-monthly meetings, City staff will provide quarterly presentations on upcoming projects, pending projects, and completed projects. Staff presentations will ensure Senior Council will obtain current information regarding senior center facility projects.

The Strategic Plan for Aging Subcommittee was developed in response to the planning and development of City of Irvine's Strategic Plan for Older Adult Services 2023 through 2028 (Plan). The Plan was adopted by City Council on November 28, 2023, and the implementation of identified goals and strategies has commenced. In lieu of bi-monthly meetings, City staff remain committed to providing quarterly presentations on the accomplishments achieved each quarter, while sharing objectives for the upcoming quarter. Additionally, staff will provide annual presentations highlighting accomplishments and outcomes for each fiscal year.

In the absence of the Facilities Subcommittee and the Strategic Plan for Aging Subcommittee, the Chair may establish ad hoc committees comprised of Senior Council members to accomplish tasks within a defined period of time to support goals related to facilities and the Plan.

ALTERNATIVES CONSIDERED

Senior Council may choose to retain one or both subcommittees and designate representatives of the Irvine Senior Citizens Council to attend each subcommittee's meetings.

FINANCIAL IMPACT

There is no financial impact as a result of dissolving one or both Senior Council subcommittees.

RECOMMENDED ACTION

Designate representatives of Irvine Senior Citizens Council to attend meetings of the Orange County Older Adults Advisory Commission and the Irvine Senior Citizens Council Nutrition Subcommittee.

EXECUTIVE SUMMARY

Irvine Senior Citizens Council (Senior Council) serves as an advisory body to City Council on policy matters affecting older adults and their families. Member participation in committees at both the County and local level is important to remain informed on matters affecting older adults.

Senior Council is requested to identify representatives for calendar year 2024 to attend meetings of the Orange County Older Adults Advisory Commission (OCAAC) (Attachment 1), and to serve on Senior Council Nutrition subcommittee (Attachment 2).

COMMISSION/BOARD/COMMITTEE RECOMMENDATION

Not applicable.

ANALYSIS

OCAAC advises the Orange County Board of Supervisors and the Office on Aging on matters affecting older adults in the county. OCAAC holds monthly general meetings, bringing service providers and advocates together to advise on relevant issues such as: senior needs assessments, service planning, and legislative advocacy. OCAAC is described as follows:

Orange County Older Adults Advisory Commission (OCAAC) – Consists of 40 volunteer citizens, including local elected officials; representatives of health care and supportive service provider organizations; persons with leadership experience, and members of the general public. OCAAC membership is comprised of at least half the members being aged 60 and older. The Orange County Board of Supervisors appoints 10 members; the California League of Cities appoints 10 members; and the Executive Board appoints the remaining 20 members.

Senior Council's Nutrition subcommittee advises Senior Council and staff on matters affecting Irvine seniors, including programs and services at Lakeview Senior Center, Rancho Senior Center, and Trabuco Center.

Nutrition Subcommittee – Raises awareness of senior nutrition topics and solicits input on nutrition program operations and menus. Provides input on nutrition-related special projects and events.

ALTERNATIVES CONSIDERED

Senior Council may decide to delay the selection of committee assignments until a future meeting.

FINANCIAL IMPACT

There is no financial impact as a result of selecting Senior Council representatives to attend committee meetings for 2024.
