

PUBLIC MEETING **COMMUNITY SERVICES COMMISSION** July 17, 2024, at 5:30 P.M.



DESCRIPTION:

The City of Irvine is seeking Community Services Commission direction on proposed modifications to Oak Creek Community Park related to a proposed new planned dog park and relocation of one of the two soccer fields. The Community Services Commission previously approved a concept plan for these projects at its April 19, 2023, meeting. Staff is requesting reconsideration of that concept plan approval based on technical issues identified during development of the construction plans for this project.

PROJECT LOCATION:

Oak Creek Community Park, which is generally located on the north side of Barranca Parkway, east of Valley Oak Drive and west of Sand Canyon Avenue in Planning Area 12 (Oakcreek).
