EXECUTIVE SUMMARY

The Orange County Transportation Authority (OCTA), on behalf of the Federal Transit Administration Section 5310 Grant Program (FTA 5310), provides opportunities for local public agencies and nonprofit organizations to help meet special transportation needs for seniors and individuals with disabilities. The OCTA's Enhanced Mobility for Seniors and Individuals with Disabilities (EMSD) Program was developed to support local agencies in the delivery of FTA 5310 eligible activities, retaining all beneficial elements of the federal program via local administration. The OCTA opened the EMSD Program funding process on May 25, 2024 offering two funding priorities, capital and operational.

The EMSD Program is intended to meet the transportation needs of older adults and people with disabilities when traditional transportation services are unavailable, insufficient, or inappropriate to meet these needs. The City of Irvine's (City) TRIPS Program (TRIPS) has been in operation since 1990 and provides low cost, door-to-door, wheelchair accessible transportation for Irvine residents ages 18 and older who are unable to drive due to a physical or cognitive disability. To address projected future increased demand for services, the City has applied for EMSD funding for six hybrid minivans, six mobile tablets, and software modules valued at \$652,000 to support the expansion of senior transportation services to meet Irvine's projected senior population growth.

ANALYSIS

The City strives to create a community where adults can age safely and with dignity through the offering of over 300 programs and services for seniors. Access to community resources like senior centers, shopping destinations, places of worship, and medical facilities are essential to the well-being of older adults. The City's Strategic Plan for Older Adults 2023 through 2028, and Transit Vision Study 2022, call for the implementation of new strategies for improving mobility and accessibility especially for socially and/or environmentally vulnerable communities.

The City currently operates the TRIPS program which provides low-cost, wheelchairaccessible transportation to Irvine older adults and adults with disabilities. TRIPS supports independent living and community involvement through safe, reliable, and professional paratransit service. All participants must be unable to drive due to a physical or cognitive disability. Given many seniors would prefer to retain their driver's license, TRIPS falls short of meeting the needs of those seniors who seek an alternative to driving to access local amenities and supportive services. Therefore, the City seeks EMSD capital grant funds to enhance transportation services to be easily accessible to all residents over the age of 60.

As a requirement of the EMSD application process, a public hearing must be conducted to document there are no nonprofit organizations readily available to carry out the proposed service enhancements. To fulfill this requirement, public notices were posted in seven public locations, on the City's website, and published in the Orange County Register on June 18, 2024. The City has fulfilled its obligation to notify nonprofit transportation providers regarding the City's submittal of the EMSD Program grant application and their right to speak at this public hearing.

ALTERNATIVES CONSIDERED

If a nonprofit organization comes forward to indicate it is willing, interested, and capable of providing the proposed service, the public comment(s) will be submitted on or before July 31, as required by the OCTA. The City's grant application would then be delayed until it is determined there is merit to the nonprofit's proposal. There would be no further action required from the Senior Citizens Council.

FINANCIAL IMPACT

There is no financial impact as a result of the recommended action.

PARTICIPATION IN SENIOR COUNCIL MEETING

Ryan McGraw, Community Services Superintendent, provided instructions on how to participate in the Senior Council meeting for those attending via Zoom or in person.

INTRODUCTIONS

1. PRESENTATIONS

1.1 Distinguished Service Award: Annette Kennedy

Vice Chair Baradehi presented this award to Annette Kennedy for her dedicated service to the Meals on Wheels Program, providing 203 volunteer hours, delivering meals to Irvine's homebound older adults, and training new volunteers.

1.2 Medication Management and Polypharmacy

Dr. Bill Liu from Orange County Health Care Agency presented on the prevalence of medication and dietary supplement use, chronic diseases, and changes in anatomy and physiology in older adults, along with suggested medication management strategies.

Discussion included: the importance of keeping an updated medication list with details from reliable sources such as the Food and Drug Administration, NIH, Office of Dietary Supplements, and primary physician; the process of pharmacy medication refills; safety measures for refills.

1.3 Elder Abuse Prevention Training

Officer Shiree Lind, Irvine Police Department, presented on fraud prevention, including examples of scams occurring in the community, along with prevention tips and resources.

PUBLIC COMMENTS – NON-AGENDIZED ITEMS

Lillian Hollar, a field representative from the office of Cottie Petrie-Norris, Assembly Member of the 73rd District, provided an update on the upcoming annual Scam Stopper event scheduled for September 19. The event will include participation from the California Department of Insurance, the Department of Financial Protection and Innovation, and the Contractor State Licensing Board, focusing on scam prevention and next steps for victims.
