- OCTA offers reduced bus fares for riders 60 years or older.
- OCTA Transit Training is available to all county residents, offering instruction on how to plan for and ride the bus.
- Transportation resources can be found through the 211 program, or on their website at www.211ride.org.
- The Office on Aging has met with members of the Orange County Board of Supervisors to discuss OCOAAC goals for 2024-25.
