



PLEDGE OF ALLEGIANCE

1. PRESENTATIONS

1.1 RED HILL GYMNASIUM

Collum McLaughlin, Community Services Supervisor, presented on upcoming plans for the new Red Hill gymnasium including the building layout, the tentative opening timeline, hypothetical schedules of activities, and potential floor layouts.

- Chair Bertoni asked if parking would be charged. Steven Stewart, Community Services Superintendent, noted there were no discussions of that at this time.
- Committee Member Lemmon asked if there was an estimated timeline for determining which sports would be included as facility users.
- Committee Member Ebert noted not all flooring can be accommodated for all sports. He suggested the permanent flooring should focus on basketball, with a mobile sports court that can be placed on top to accommodate other sports.
- Chair Bertoni noted it does not make sense to have badminton specific flooring and for a sport not represented in the Sports Committee.
- Committee Member Doyle asked if there was data to justify having badminton only courts in the facility, noting it did not seem equitable to have badminton only courts when other sports must share fields for various use.

There were two public comments.

- Kinngai Chan provided background on the number of participants in the City of Irvine contracted badminton courses. He also commented that the new gym would not have been possible without the badminton community.
- Herson Go shared the need to include table tennis in the new facility, noting only a few community centers currently have spaces for that sport.

PUBLIC COMMENTS – NON-AGENDIZED ITEMS

Chair Bertoni shared a new law will be in effect starting in 2026 requiring an AED and trainer onsite for all youth sports activities.

- Superintendent Stewart noted that once the state solidifies what that means, the City of Irvine will determine the approach and impacts on youth groups. He clarified it is one AED per location, not individual field.

Chair Bertoni also shared that City Council approved synthetic turf installation on soccer fields four through seven at the Great Park. He noted additional approval for synthetic turf on fields fourteen through seventeen will need to go back to City Council.

EXECUTIVE SUMMARY

Established in 1979, the Irvine Sports Committee (Committee) serves as an advisory body reporting to the Community Services Commission. The Committee's purpose is to provide input on the needs of the community pertaining to Irvine's youth sports programs, facilities, and services. The Committee also strives to ensure the equitable allocation of athletic facilities.

The Committee meets quarterly to review field allocations, event calendars, and reservation and allocation policies and procedures. The Tournaments and Events Calendar (Calendar) is attached and presented for the Committee's review, discussion, and input.

ANALYSIS

Tournaments and large events are reserved in accordance with the Athletics Facility Reservation Policy. This Policy provides priorities and methodologies for approving tournaments and large events while meeting the needs of the Irvine community.

The Calendar is created to document tournament and large event requests that extend beyond the activities in the seasonal allocation process. While events remain in the planning process, the Committee reviews the Calendar to ensure facilities are adequate to meet the needs of the event, and the needs of local programs.

ALTERNATIVES CONSIDERED

The Committee may request a modification of one or more events.

FINANCIAL IMPACT

Modifications to the Calendar resulting in a reduction of tournament hours may have a financial impact.
