ACTION: Moved by Board Member Carrera, seconded by Vice Chair Howard and unanimously carried by those members present, (Board member Baba absent) to:


- 1) Approve the aquatics centers' Special Events Calendar dated January 22, 2025; and include the following 2026 and 2027 events:
