#### RECOMMENDED ACTION

#### **EXECUTIVE SUMMARY**

The Older Adult Services Proposed Budget for Fiscal Years 2025-26 and 2026-27 (Proposed Budget) is presented to the Irvine Advisory Commission for Older Adults (Commission) for review and input. The Commission has the duty to act in an advisory capacity to the City Council in establishing policy on all matters pertaining to the special interests and concerns of older adults, consider the proposed annual budget, and make recommendations to the City Council and City Manager.

The Proposed Budget was developed with the needs of Irvine older adults in mind and aligns with the City's commitment to fiscal responsibility and effective management. The City Manager and/or City Council may adjust the Proposed Budget to incorporate recommendations made by the Commission, community requests, or other revisions prior to adopting the final budget. The Commission will be notified if any adjustments are made to the Older Adult Services section of the budget.

The Proposed Budget for Older Adult Services consists of General Fund and Special Fund proposed appropriations as listed below:

#### **ANALYSIS**

The Proposed Budget was developed to meet City Council's priorities and supports the implementation of the Strategic Plan for Older Adult Services 2023 through 2028. The Proposed Budget is comprised of the General Fund and Special Funds as described below:

#### General Fund

The Proposed Budget was developed with the goal of enhancing City services while considering potential challenges such as economic slowdown, a tightening labor market, and increasing costs for supplies and services. Table 1 illustrates the proposed General Fund budget for Senior Services section.

The following is a summary of the primary areas for proposed funding.

<u>Expenditures</u>: Year 1 Proposed Budget of \$3,906,443 is approximately a 25 percent increase from Fiscal Year 2024-25 adjusted budget of \$2,896,325. Year 2 Proposed Budget of \$4,047,656 is approximately a 3.5 percent increase from Year 1. These variances are due primarily to the following:

#### □ Salaries and Benefits

- Year 1: Increase of approximately 28 percent (\$732,493) from Fiscal Year 2024-25 due to increases in salaries and benefits.
- Year 2: Increase of approximately five percent (\$169,437) from Year 1

#### □ Services and Supplies

- Year 1: Increase of approximately 114 percent (\$277,625) from Fiscal Year 2024-25 due to increase in contract instructor payments for programs and services.
- Year 2: Decrease of approximately five percent (\$28,224) from Year 1

Revenue: Year 1 projected revenue of \$734,023 is an increase of approximately 24 percent (\$175,991) compared to Fiscal Year 2024-25. Year 2 projected revenue of \$746,023 is an increase of approximately two percent (\$12,000) compared to Year 1.

#### Special Fund 126 - Senior Services Fund

Table 2 illustrates the Proposed Budget for Special Fund 126 which dedicates restricted funds to support various programs and services for older adults, such as. Special Fund 126 includes private donations and interest earnings from two endowments. Budgeted funds not expended during the Proposed Budget will remain as fund balance.

<u>Expenditures</u>: Year 1 Proposed Budget of \$58,300 is approximately a 37 percent increase from Fiscal Year 2024-25 adjusted budget. Year 2 Proposed Budget of \$43,330 is approximately a 35 percent decrease from Year 1. The Proposed Budget accounts for anticipated costs across 12 sub-funds to pay for services, supplies, and equipment for special interest programs not supported by the General Fund.

#### Special Fund 128 – Elderly Nutrition Programs

Special Fund 128 was originally established to receive federal and state funds for the Elderly Nutrition Program and manage program expenditures. The transfer of program administration to Age Well Senior Services in 2022 created an opportunity to streamline the Older Adult Services budgets. Expenditures previously allocated to Special Fund 128 have been moved to Older Adult Services Special Fund 126 for this new budget cycle.

#### FINANCIAL IMPACT

The Proposed Budget for Older Adults Services is \$3,906,443 for Fiscal Year 2025-26 and \$4,047,656 for Fiscal Year 2026-27 in General Funds.
