PARTICIPATION IN COMMITTEE MEETING

1. IRVINE FIELDHOUSE

Collum McLaughlin, Community Services Supervisor, presented upcoming plans for the new Irvine Fieldhouse including the building layout, the tentative opening timeline, hypothetical schedules of activities, and potential floor layouts.

- Committee Member Dallas commented that the Sports Advisory Committee did not make a recommendation on the number of badminton courts and requested a motion to City Council.
- Superintendent Stewart advised that the direction on the number of courts came from City Council. He noted a motion could not be made on a presentation; however, the topic could be agendized on a future meeting, or a special meeting could be called.
- Chair Bertoni commented there is not a concern with having badminton activities in the facility, but rather if there should be dedicated badminton courts.
- Moved by Committee Member Dallas, seconded by Committee Member Lambeth and unanimously carried out by those members present (Committee Members Doyle, Torrez, Tristian, Analui, Dixon, Hess, McNab, Lemmon, Bhangay, Suraweera, and Ebert absent) to agendize the topic of dedicated badminton courts in the Irvine Fieldhouse at the next meeting.
- Further discussions were then had amongst the committee about facility fees, reservations software, insurance, and facility programming.
- Committee Member Owens brought up concerns about prioritizing Irvine over non-Irvine residents and who is using the facility
- Moved by Committee Member Dallas, seconded by Committee Member Lambeth and unanimously carried out by those members present (Committee Members Doyle, Torrez, Tristian, Analui, Dixon, Hess, McNab, Lemmon, Bhangay, Suraweera, and Ebert absent) to agendize the topic of Irvine Fieldhouse facility usage at the next meeting.

- City Council updated all City commission and committee bylaws to be consistent.
- Landscaping is creating more warm-up space within the Great Park softball complex and more parking is being added in parking lot six where the current dirt lot is.
- Great Park soccer fields 4 through 7 will be four artificial fields. The flex field is still in the planning phase to be converted into a large artificial turf field.

EXECUTIVE SUMMARY

Established in 1979, the Irvine Sports Advisory Committee (Committee) serves as an advisory body reporting to the Community Services Commission. The Committee's purpose is to provide input on the needs of the community pertaining to Irvine's youth sports programs, facilities, and services. The Committee also strives to ensure the equitable allocation of athletic facilities.

The Committee meets quarterly to review field allocations, event calendars, and reservation and allocation policies and procedures. The Tournaments and Events Calendar (Calendar) is attached and presented for the Committee's review, discussion, and input.

ANALYSIS

Tournaments and large events are reserved in accordance with the Athletics Facility Reservation Policy. This Policy provides priorities and methodologies for approving tournaments and large events while meeting the needs of the Irvine community.

The Calendar is created to document tournaments and large event requests that extend beyond the activities in the seasonal allocation process. While events remain in the planning process, the Committee reviews the Calendar to ensure facilities are adequate to meet the needs of the event, and the needs of local programs.
