Hi Collum,

I saw that Heritage Park is going to add pickleball courts as a part of their improvements plan. I have a comment to make about these new courts but would like to speak more to the existing courts at Heritage Park.

I play pickleball at both Portola Springs and Heritage Parks during the week, Heritage is closer to where I live and consider it my home park. Playing at both allows me to see the plus/minus between the two locations so I have the following suggestions for improvement:

- Heritage Park remove the tennis court net and replace it with the three foot chain link fence. This fence should extend the full width to the side fencing with gates at both ends. Balls always find a way to wherever an opening exists, a full length fence with gates will minimize balls rolling from one set of courts to the other.
- Portola Springs extend the three foot fencing between courts 1&2 and 3&4 and extend the three foot fencing between courts 3&4 and 5&6 by adding gates. As mentioned, balls always find a way to wherever an opening exists, a full length fence with gates will minimize balls rolling from one set of courts to the other.
- Heritage Park add wind barriers to all the exterior fences. This cuts down on wind and on hot days it can provide some shading

New Heritage Park courts comment. I see the courts are going to lay side by side. Hopefully this provides more space behind the baselines and barriers - the existing courts currently have a short area behind the baselines and the tennis net. For the new courts you may want to expand the overall court area along the outer length to provide for space if its needed.

Thank you for the opportunity to review the City of Irvine (City) Heritage Park Master Plan (Project) for potential environmental impacts on the Irvine Unified School District (District) schools. The District has reviewed the Mitigated Negative Declaration and Initial Study made public on November 14, 2024 and offers the following comments.

<u>Comment 1:</u> 1.4.1 Proposed Land Use (Page 11, third paragraph): The City cites "...the small expansion of an existing parking lot would eliminate a soccer field." The District requests that the City consider and make available a soccer field (or provide a new soccer field) to replace the current soccer field eliminated as a result of the Project.

Comment 2: 1.4.4.3 Drainage System (Page 18, second paragraph): The improvements along Escolar street will significantly impact the Irvine High School. The District requests that the City coordinate the improvements along Escolar street with the District to mitigate impacts to Irvine High School's operations and traffic. Moreover, the District requests that these improvements occur during the summer when the high school is on summer break. As part of the drainage system, there is a proposed bioretention basin and Filterra units mentioned in the study. The District requests that the location be coordinated with the District and high school.

<u>Comment 3:</u> 1.4.5 Project Construction and Phasing (Page 19): Project construction duration "...is anticipated to occur over a period of approximately four years, from December 2024 to December 2028". The District requests the City provide more specific construction timelines when the information becomes available.

<u>Comment 4:</u> 2.1 Project Information (Page 22, Item 10): The City states "Not Applicable". The Joint Use Agreements between the City and District, specifically for the Northwood and Heritage Aquatics Pools, states under Article 4, subsection 4.11, that "Alteration of the Facilities and Improvements constructed pursuant to this agreement, or construction of additional Facilities and improvements,

shall be undertaken only with the mutual written consent of the City and District, after costs have been determined and agreed upon in writing in advance. The consent of either party shall not be unreasonably withheld." The District's Board of Education is required to approve and grant permission for the portions of the Project which are on District property. In addition, the design and construction approval and oversight for work on District property shall be under the jurisdiction of the California Department of General Services, Division of the State Architect.

<u>Comment 5:</u> 3.1.c). Project Construction Phase (Page 35): The District requests that the City coordinate work prior to starting construction on District property for the Woollett Aquatic Expansion improvements, including but not limited to an Entry Permit, easements, etc.

<u>Comment 6:</u> 3.17.a). Impact to Alternate Modes of Transportation Facilities (Page 105): The District requests that the design of the Heritage Community Park parking lot, along Walnut Avenue, consider appropriate access for students, pedestrians, and cyclists westbound on Walnut Avenue allowing access to Irvine High School as commensurate with Title V of the California Code of Regulation, Section 14030 subparagraph B.

As you are aware, it is the District's desire to continue working collaboratively with the City in order to maintain the District's reputation for high quality education. We look forward to working closely with the City throughout this CEQA process and to continue our ongoing discussions.

Dear Mrs. Haton:

I hereby oppose the current "Heritage Park Master Plan for the long-term rehabilitation of Heritage Community Park including an array of improvements to the park grounds and facilities".

I have been an Irvine resident since 1985 and have lived at current address for almost 24 years. My residence is in walking distance from the park and I pass by it on Walnut Avenue daily.

My opposition is based on the following:

- Increases traffic and traffic congestions
- More than double the number of visitors, in access of 2,000,000, per year
- Increase of pollution
- Loss of park land and possibly sports facilities
- Cost of project

Detailed explanations:

Community outreach:

According to the "Heritage Park Draft Master Plan", published by the city in September 2023, the City conducted a "community outreach effort" in 2019, but neither my neighbors nor I have been contacted or even heard about the plan. Further, it states that more than 100 participants took part in a community meeting and over 60 attended workshops. These participants represent

less than 0.04% of Irvine's population, considering that Irvine had about 279,000 residents in 2020. This is for sure no representative of the residents that live around the park.

Traffic and Pollution:

The plan does not address the now completed Performing Arts Center at Irvine High and its impact on the additional traffic and parking.

As it stands Walnut Ave is regularly congested around the entrance to the Woollett Aquatics Center. Adding a third pool to this center will only make the traffic situation worse, in particular considering the combination of the pool and the Performing Arts Center.

Adding additional parking along Walnut Ave. will not only reduce the vegetation that desperately needed to combat pollution, but also reduce the visibility of the park from the street.

According to the "Heritage Park Master Plan - Public Draft Initial Study-MND" at the time of writing the report the daily vehicle trips stood at 1,332. After the completion of the proposed changes this would add 1,349 trips to the park, i.e. it would more than double the traffic in and out of the park, to 2,681 trips and triple the trips during pm peak hours. This would strain the traffic congestion on Walnut Ave. even more. Please note, the current and future trips add up to 2,681, but the report states 2,671 daily trips.

I do not have copies of the Appendices A through F mentioned in the report, therefore, I could verify the emission numbers stated for both the construction phase and regular usage.

It would be my guess that the residents around the park will see an increase in exposure to the pollution stemming from equipment during the construction period, as well as from more than double the number vehicles that will enter and leave the park in the future.

Demolition Work:

There is no consideration of the possible negative impacts of the demolition of the currents structure. Do they contain asbestos and or other toxic materials?

I am questioning the Priorities:

- Why is the 50 m pool on top of the list?
- Adding parking along Walnut Ave. contradicts the overarching consideration of "Create street visibility of park to improve connection to community", as the parking would block the view of the park.

• Adding parking to the NW corner is possibility, but it is a very inconvenient location for dropping people off, as it is the furthest away from the park, in addition to the fact that existing from Escolar to Walnut could be troublesome. People would use easier dropoffs. Not to mention that Escolar us a two lane road and backs up during events, which would be even worse by adding 321 more parking spots.

Communities around the park:

It is interesting to read that "...no data is available regarding the reaction to the temporary impacts due to construction at the park", Under Reports and Studies it talks about "community outreach effort", as well as "A high level participants provided valuable insight..." and "community workshops" Did no one address the construction impacts during these sessions?

It is absolutely imperative that the residents around the park need to be contacted and surveyed to gain information on their perspective. These should include residents in the neighborhoods of El Camino Real, as they would be impacted the most not only by the construction, but also by the future changes in traffic.

Costs and Funding:

In the plan there is no mentioning of where the funding would be coming from.

The plan estimates the overall costs in 2020 of over \$70 million, which equates to close to \$100 million today. According to the Associated Builders and Contractors reports that building material costs have increased by 37.7% since 2020. This is more than one third of the city's 2024-2025 budget. Where is this money coming from?

In closing, I like to reiterate that I oppose the current Heritage Park Master Plan for the long-term rehabilitation of Heritage Community Park including an array of improvements to the park grounds and facilities.

As the outreach activities were performed more than five years ago, beginning of 2019, it would necessary and advisable to involve the communities in El Camino Real in this project as they would affected the most by any changes.

Thank you for the opportunity to express my thoughts. I would be more than happy to get deeply involved in future projects concerning the city of Irvine.
