PLEDGE OF ALLEGIANCE

Chair Pro Tem Agran led the Pledge of Allegiance.

INTRODUCTIONS

Steven Chen, Deputy Director of the Mental Health Association for Chinese Communities, introduced himself and his organization, and announced that he will present at the December 8, 2025 Health & Wellness Advisory Committee meeting.

ANNOUNCEMENTS/COMMITTEE REPORTS

Chair Pro Tem Agran provided a brief presentation on what's new in pediatrics, including updates to immunization schedules, mental health screening, home health care for children with complex needs, prevention of child drowning, and electric bikes.

ADDITIONS AND DELETIONS

There were no additions or deletions to the agenda. However, Director Dion requested that item 4, *Early Childhood Friendly City Resolution*, be moved up in the agenda to follow presentation item 1, *OC Children's Screening Registry*, to petter accommodate the outside agency guests.

DIRECTOR'S REPORT

Director Dion announced the City's inaugural Nonprofit Week 2025 and shared details on the planned events.

She also shared information on the monthly food box distribution, which occurs on the second Thursday of each month from 9 a.m. to noon at Heritage Fark, and mentioned it being a volunteer opportunity for individuals aged 18 and older.

NOMINATION AND SELECTION FOR CHAIR AND VICE CHAIR

One nomination was received for Chair Pro Tem Agran to serve as Chair for the remainder of the 2025 calendar year. The nomination period was then closed.

1. OC Children's Screening Registry

Traci Stubbler, Child Care and Development Superintendent, introduced Jaquelyn Norton, Screening Registry Coordinator from Help Me Grow Orange County, who presented the item on the OC Children's Screening Registry platform.

4. EARLY CHILDHOOD FRIENDLY CITY RESOLUTION

Traci Stubbler, Child Care and Development Superintendent, introduced Cristina Blevins, Early Learning Senior Program Officer from First 5 Orange County, who presented the item on the Early Childhood Friendly City Resolution.

Committee members engaged in discussion and asked questions of Ms. Blevins.

There were no public comments received.

ACTION: An amended motion was made by Committee Member Inmon to refer the item to the Early Childhood Ad Hoc Subcommittee for further review and development and bring the updated item back at the next regular meeting of the Health & Wellness Advisory Committee. The motion was seconded by Committee Member Haq and passed unanimously with all members present.

COMMITTEE BUSINESS

3. HEALTH AND WELLNESS ADVISORY COMMITTEE SUBCOMMITTEES

Director Dion presented the item, and following discussion among the committee, five Ad Hoc Subcommittees were formed, with members self-selecting based on their areas of interest and expertise:

The Committee established that all subcommittees will include an overarching focus on safety and injury preventior, as well as environmental health. Collaboration with other City departments and community partners, such as UCI, Irvine Valley College, and other subject matter experts, is encouraged and expected as part of the subcommittees' work.

There were no public comments received.

ACTION: Moved by Chair Agran, seconded by Committee Member Hamilton, to affirm the formation of the subcommittees and their membership. The motion passed unanimously with all members present.
